Todd Township Annual Meeting – March 08, 2022 – 7:00 PM

The Annual Todd Township meeting was called to order by Todd Township Clerk Pat Cadreau with the Pledge of Allegiance. 11 residents were present with 7 guests. Sign in sheet is attached.

Clerk Cadreau entertained a motion to choose a moderator for the 2022 Todd Township Annual meeting. Jim Schauer nominated Keith Mikus as Moderator for the meeting, seconded by Ron Jensen. Clerk asked three times for other nominations, there being none, Clerk called for the vote– Keith Mikus was elected Moderator for the 2022 Annual meeting.

Moderator Mikus continued the meeting with Clerk reading the minutes from March 9, 2021 and reconvened meeting on September 13, 2021, motion by Maureen Petersen that minutes be approved as corrected 2nd paragraph in reconvened meeting in September read budget for 2022 not 2021, motion was seconded by Ron Petterson, there being no discussion motion was passed.

Kim Donahue spoke for **Living at Home** help elderly neighbors and friends to stay in their homes. 3,000 volunteer hours and 19,000 miles

Maureen Peterson/Cindy Little spoke for Hubbard First Responders on call 24/7. 700-800 calls in 2021, always adding to team, donations go toward funding education of new team members. Have 32 members, take on 3-5 new members every year. Totally volunteer.

Jan Rumpza Hubbard County Historical Society – 2nd & 3rd graders will be visiting this year, ~ meet last Monday of every month May thru September.

Cory Nelson/Angie Ness Byer Support Within Reach – provide education on sexual violence prevention in schools (335 participants in Hubbard) Confidential services is provided to all who have been effected – free of charge

Maria Presser spoke for **Kinship** – mentoring program, volunteer adult with an adolescent – 24 matched, are looking for matches for 10 (3 girls, 7 boys).

Maria Presser spoke for **Library** 792 Todd Township residents have library cards. 501 3c Friends of the Library.

Moderator Mikus explained their requests will be looked at in April, 2023.

FIVE YEAR ROAD REPORT – distributed for residents to review. Moderator Mikus explained it is a plan to keep Todd Township roads in good shape so they do not have to be replaced.. Nothing was done in 2021 because of Enbridge pipeline going through township. Maureen Petersen asked question on funds for road work. Schauer explained that Todd Township will probably be spending more than \$4,000.00 on roads in 2022.
