Motion by Meier that agenda be approved as amended, add Public Input: Rotary motion was seconded by Mikus, no discussion and motion passed Foundation: unanimously.

Motion by Meier to approve minutes of the January 14, 2019 Township Board meeting, motion was seconded by Mikus, no discussion and motion passed unanimously.

Motion by Schauer that Treasurer's report for January be approved as presented, motion was seconded by Meier, no discussion and motion passed unanimously.

PUBLIC INPUT: Christine Fox asked for approval of gambling permit for Rotary Foundation. Motion was made by Meier to approve gambling permit for Rotary Foundation, motion was seconded by Mikus, no discussion and motion passed unanimously. County Sheriff Deputy Craig Kristzeck was present, asked if there were any problems in Todd Township. There being none.

ROADS: 5 year road plan was handed out for viewing. Will be discussed at Annual Meeting in March 12, 2019. Question: Will city of Park Rapids pay for half of the paving for Albert Ave.?

TODD TOWNSHIP BOARD MEETING RECESSED AT 7:30 P.M. Reconvened Public Hearing for Larry and Kathy Grell

Hand out from Town Board's Attorney Robert Ruppe was handed out. 1) Motion by Supervisor Mikus that the Town Board find that the property owners are in violation of the Conditional Use Permit issued by the Town Board on June 24, 2014 and recorded as document number A000372685 in the Office of the Hubbard County Recorder for the following reasons: 1) that the property owners have failed to construct a home on the property by June 24, 2017 as required by condition number 3 of the Conditional Use Permit; and 2) that the property owners have failed to increase tree plantings on the property around and near the neighboring properties to the North, West and South to provide screening as required by condition number 2 of the Conditional Use Permit as the property owners have planted no trees on the property, motion was seconded by Supervisor Meier, and passed unanimously with no discussion.

2) Mikus further moved that Township board be authorized to work with the property owners to modify the CUP such that the violations no longer exists and that

any proposed amended CUP be presented to the Town Board for consideration at its March regular board meeting, motion was seconded by Meier and passed unanimously without discussion.

Motion by Meier that Grells pay fees that have incurred, motion was seconded by Mikus and passed unanimously.

Motion by Meier that Public Hearing be recessed to March 11, 2019 at 7:30 p.m., motion was seconded by Mikus and passed unanimously. Schauer reconvened Todd Township Board meeting at 7:45 p.m.
