Regular Town Board Meeting – June 14, 2021– 7:00 PM

Supervisor Chair James Schauer called the meeting to order with the Pledge of Allegiance.

Present: Supervisors Schauer, Bob Meier, Keith Mikus, Treasurer Sue Zinniel and Clerk Pat Cadreau.

Motion by Meier that agenda be approved as amended, **adding C. CD renewals to Clerk & Treasurer’ report**, motion was seconded by Mikus, and motion passed unanimously.

Motion by Mikus to approve minutes from May 10, 2021 Todd Township Board meeting, motion was seconded by Meier and motion passed unanimously.

Motion by Mikus to approve May 2021 treasurer’s report, motion seconded by Meier and passed unanimously. Motion by Mikus that CD 17465, 17466, 17467 and 17468 renew for 6 more months, motion seconded by Meier and passed unanimously.
